MOI seeks to restore mobility and independence to amputees and other physically disabled children and adults in developing countries by providing access to prosthetic care, orthopedic surgery, and clubfoot treatment. Through local capacity building, MOI facilitates lifelong access to orthopedic services for physically disabled individuals to help them live healthy, productive lives.

PROSTHETICS & ORTHOTICS PROGRAM ACCOMPLISHMENTS: 339 prosthetics and orthotics individual patients served in Bangladesh, Sierra Leone and Haiti. Manufacture of 50 Bending Feet in Sierra Leone using improved design created based on amputee feedback. In response to the Ebola epidemic, Mobility Outreach International provide the team in Sierra Leone along with the Makeni Hospital staff personal protection gear. In Haiti, the local prosthetist candidate successfully completed all 5 modules for the prosthetics and orthotics certification. Continued partnership with Nalta Hospital in Bangladesh to provide P&O services.

CLUBFOOT PROGRAM ACCOMPLISHMENTS: 704 children with clubfoot were treated in Vietnam, Haiti and Sierra Leone using the Ponseti Method which requires a series of casts and the wearing of braces for foot correction. In Vietnam, the Ponseti Method was accepted by the Ministry of Health as the first line treatment for babies born with clubfoot and it is incorporated into the national insurance scheme. In Sierra Leone, protocols were put in place to protect the team from Ebola and personal protection gear was provided. In Haiti, the only local foot abduction brace manufacturer produced 60 braces for clubfoot treatment.

ORTHOPEDIC SURGERY PROGRAM ACCOMPLISHMENTS: 87 patients received surgery in Vietnam through partnership with the American Foot and Ankle Society (AOFAS) and through MOI's Medical Director. 119 Vietnamese Orthopedic Surgeons were trained by visiting surgeons.
